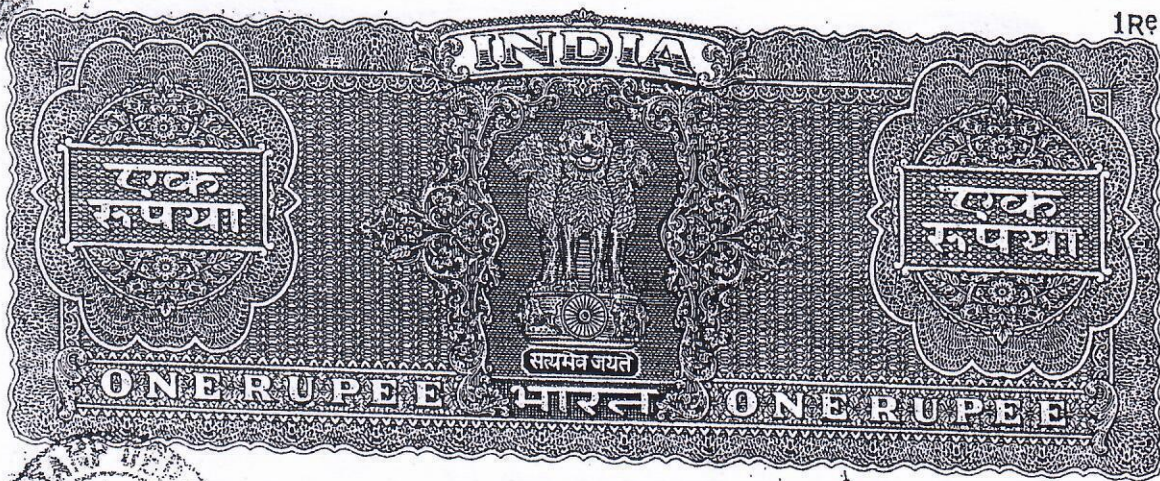

(g) To do all other ameliorative and developmental services to all socially, economically and educationally backward classes, especially the scheduled Caste and Scheduled Tribe Christians irrespective of caste, creed or colour.

4. ADMINISTRATION OF THE TRUST

- (a) The founder will be the trustee for life. When he finds it inconvenient or impossible to discharge his duties and functions as trustee, he may nominate any fit person in his place. If this course could not be adopted, the Advisory Committee may elect a proper and fit person as trustee.
- (b) To assist the trustee there shall be an advisory committee consisting of five members nominated by the trustee. The functions and powers of the Advisory Committee shall be prescribed and regulated by the trustee.

- (c) The members of the Advisory Committee shall hold Office for one year. If any member of the Advisory Committee is found to have acted against the objects of the trust or does anything detrimental to the interest of the trust, he can be expelled from the Committee by the trustee without assigning any reason.
- (d) The meetings of the trust may be convened by the trustee whenever necessary.
- (e) The members of the Advisory Committee shall assist the trustee giving full co-operation to him.
3. FUNCTIONS AND POWERS OF THE TRUSTEE
- (a) The trustee shall have full powers of administration of all the affairs and activities of the trust.
- (b) All Correspondences, both out-ward and inward, shall be conducted by the trustee.

- (c) The trustee shall be the authority, for appointment, discipline and dismissal of staffs and workers in the various institutions under the trust. He shall be the authority to prescribe the service conditions and fixing the pay, allowances etc. of the staffs and workers of the trust.
- (d) The trustee shall maintain all accounts, records and registers.
- (e) The trustee shall be responsible for all receipts and expenditure of the trust and he shall operate the bank accounts relating to the trust.
- (f) The trustee shall have powers to equip, furnish or otherwise fit up and conduct educational institutions necessary or useful for the carrying out of the objects of the trust.
- (g) The trustee shall have powers to purchase sell, mortgage, or lease properties and incur all expenditure necessary or incidental to executing the various affairs and activities of the trust.
- (h) The trustee shall be the person to sue or to be sued for and on behalf of the trust.
- (i) The trustee may delegate any power to any staff or person or committee for any specific purpose or programme of the trust.
- (j) The trustee has the powers to raise funds by gifts and donations or by loans with or without the security of the properties of the trust.

6. THE FINANCE OF THE TRUST

- (a) The founder has donated a sum of Rs.1,000/- as initial funds of the trust.
- (b) Further donations and gifts made by the founder and other well wishers will be included in the finance of the trust.
- (c) Fees collected from students studying in the various institutions under the trust shall also be included in the funds of the trust.
- (d) Income from properties, investments and grants and aids from Government for the institutions will also be included in the funds of the trust.

7. THE FINANCIAL YEAR OF THE TRUST

The financial year of the trust shall be from April to March and all the accounts of the trust shall be closed at the end of each financial year and a statement of Receipts and Expenditure and a Balance Sheet shall be prepared and audited by a qualified auditor and signed by the trustees and two members of the Advisory Committee. Such accounts shall be proof of the financial state of the trust.

8. EXPENDITURE OF THE TRUST

- (a) All expenses, for the running of the institutions and their management and other activities of the trust shall be met from the trust funds.

(b) Proper accounts for all receipts and expenditure shall be maintained by the trustee with proper receipts or vouchers.

(c) All the accounts, records and other papers shall be in the Office of the trust under the custody of the trustee. All movables also shall be in the custody of the trustee.

9. THE PROPERTIES OF THE TRUST

Documents for the purchase or acquisition of properties for the trust shall be in the name of the trust represented by the trustee. Likewise documents to be executed by the trust shall be executed by the trustee for and on behalf of the trust.

10. DISSOLUTION OF THE TRUST

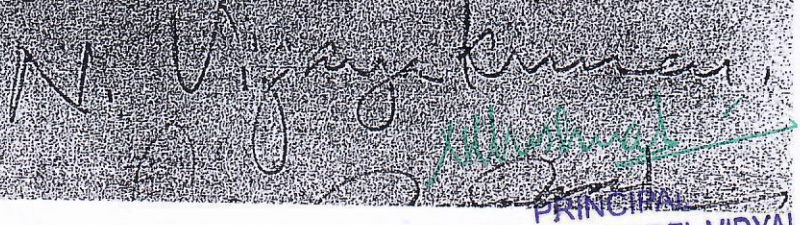
